Confirmed resolution on item No. 19 of FET Meeting dated 13.06.2010

on

Comprehensive Examination Rules & Regulation For Master Of Engineering and Technology Degrees Of Jadavpur University

Considered the existing examination rules for 4-semester PG courses (EC resolution no. 5 dated 28/05/2002 and EC resolution no. 16(b) dated 27/04/2009) where in a student's performance in any subject is evaluated on a 6-point scale providing grade points. Grades are allotted in each subject based on marks secured by the student in that subject.

Considered also the sub-committee report placed by Prof. M. Nasipuri.

Resolved that the following resolutions are passed and confirmed in the meeting for onward transmission to EC.

1. That the following table of gradation system be used for calculation of SGPA & CGPA and method of calculation of SGPA & CGPA will be same as the previous one.

% marks obtained	Performance	Grade	Grade points
90 and above	Outstanding	S	10
80 to 89	Excellent	A	9
70 to 79	Very good	B	8
60 to 69	Good	C	7
50 to 59	Fair	D	6
Less than 50	Poor	E	2

2. That a student who obtains 'E' grade in one or more theory papers in the 1st semester examination will have to sit for re-examination of those subjects during the regular examination in the next academic session. However, the student will be allowed to continue in the 2nd semester courses.
3. That a student who obtains 'E' grade in one or more theory papers in the 2nd semester examination will have to sit for re-examination of those subjects during the regular examination in the next academic session.
4. That a student will get maximum three chances (1 regular and 2 supplementary in the subsequent two academic sessions) to clear each theory paper.
5. That a student who obtains 'E' grade in a sessional paper in the 1st or 2nd semester will be declared ineligible and will be allowed to continue the course only by getting himself /herself readmitted as a regular student in the course.

6. That a student will be allowed to continue in the second semester of the Masters degree course only if he/she appears in all subjects in the 1st semester examination and a student will be allowed to continue in the second year only if he/she appears in all subjects in the 2nd semester examination.
7. That a student will be promoted to the 2nd year of the Masters Degree course only if the 1st year CGPA of the student is not below 5.0.
8. That a CGPA of 6.2 will be treated equivalent to 60% marks.
9. That, if a student fails to submit the thesis within the stipulated time (at the end of 4th semester) or obtains 'E' grade in the thesis examination and/or viva-voce, he/she will be considered as a bi-annual candidate and will be allowed to submit the thesis after six months. He/she will get one more chance at the end of the next academic session.
10. That a student will have to complete the course within three academic sessions.
11. That in case of 6-semester PG courses the same grading system of 4 semester courses will be followed.
12. That the proposed rules 2, 3, 4, 5 and 6 above for 4-semester PG courses will be followed in the 1st to 5th (wherever applicable) semesters of the 6-semester PG courses.
13. That the proposed rules 7 and 8 above for 4-semester PG courses will be followed in the 1st and 2nd year of the 6-semester PG courses.
14. That if a student of 6-semester PG course fails to submit the thesis within the stipulate time (at the end of 6th semester) or obtains 'E' grade in the thesis examination and/or viva-voce, he/she will be considered as a bi-annual candidate and will be allowed to submit the thesis after six months. He/she will get one more chance at the end of the next academic session. A 6-Semester PG Student has to complete the course within four academic session.
