Notification

The undersigned brought to the notice of all concerned regarding the solemn order of the Hon'ble High Court, Calcutta in the W.P. 27428(W) of 2014, vide the circular No REC/N/310/2014 dated 25/09/2014 for its implementation. However, the copy of the Hon'ble Court Order as well as the Circular are being enclosed once again for ready reference of all stake holders or any individual claiming to be a stake holder of Jadavpur University.

As per Hon'ble Court Order the designated place for agitation/protest/assembly was clearly stated in the circular. Moreover, it was clearly mentioned therein that for such agitation/protest/assembly in that designated place prior intimation to the University Authority was required to be given. The same had been emphasized in the aforesaid solemn order of the Hon'ble High Court. But it is a matter of great concern that some persons are carrying out the abovementioned activities in front of the administrative building. Even it is unfortunate to observe that the academic buildings are not being spared.

Perhaps without going into the depth of the Hon'ble Court Order these gross irregular activities had been carried out by the persons on 25.09.14. Such type of activities led to the violation of the Hon'ble Court order which is not at all desirable from any stake holder or any individual claiming to be a stake holder of the University. Such type of gross irregularities has virtually led to disruption of the normal work of the University. Apart from this negligence in the discharge of duties, breach of discipline and breach of orders and circulars of the University were also observed time and again. These misconducts are not at expected and desirable.

Such type of gross irregular activities and misconducts are causing great academic loss to the University and the students are becoming the worst victims. Most specifically, it is to mention that in the ongoing Semester (July'14 – Dec'14) several academic days had already been lost in the meanwhile. It would be very difficult to compensate those academic days within the prescribed duration of this Semester. If this sort of academic loss is continued then there may be no other alternative but to defer the Semester which will in turn cause the deferment of the conferment of Degrees. This will cause irreparable loss to the students pursuing studies in Jadavpur University, particularly in terms of their further higher education in different reputed institutions located all over the country and abroad as well as their employment in different organisations.

As directed, the undersigned is bringing the aforesaid facts before all stakeholders or individual claiming to be a stakeholder of Jadavpur University with a request to cooperate with the University so that there is no further academic loss to our students.

Students are advised to resume their normal classes with immediate effect.
