ADMISSION TO THE Ph.D.(SC.) PROGRAMME FOR THE SESSION 2020-21 (PHASE - II)

Applications are invited from Indian Nationals who have eligibility for admission to the Ph.D. (Science) programme as per New Ph.D. Regulation 2017 against the vacancies declared by the permanent teachers / scientists of Jadavpur University and its affiliated institution under the Faculty of Science, Jadavpur University for the session 2020-21 (Phase – II). Please go through the following instructions for details:

- All applicants must have possessed at least 2-years M.Sc. or equivalent degree from any University or Institute recognized by the UGC with requisite marks as laid down in the eligibility under J.U. Ph.D. regulation 2017.
- ➤ Candidate should apply downloading the application form available from the website (www.jaduniv.edu.in).
- ➤ Candidates have to pay the application fee of Rs. 500/- (per subject) online through SBI Collect system using Credit Card / Debit Card / Net Banking till **26.04.2021 upto 4:00 p.m.**
- Candidates have to submit the filled-in application to the Office of Dean & Secretary, Faculty of Science, UG Science Building, Jadavpur University along with the following testimonials:

 (i) two passport size photographs,(ii) attested copies of all mark-sheets and certificates from Madhyamik onwards, (iv) admit card / certificate of Madhyamik for age verification (iii) SC/ST/PD/OBC-A/OBC-B Certificate from competent authority, (where applicable), (v) NET / SET / GATE / ICMR-NET / DBT-NET, AYUSH NET certificates etc., if any, (vi) filled-in forwarding form of supervisor duly signed by the Supervisor / Supervisor and Director (in case of affiliated institute) and HOD concerned.
- ➤ Employed candidates have to fill the NOC portion of the form, duly authenticated by the competent authority.
- Vacancies shall be predetermined by the committee concerned.
- Applications for Ph.D.(Science) programme 2020-21 will be received **upto 26th April, 2021** and the date of written test (WRET) / interview will be declared later on.
- Format of Forwarding form of Supervisor will be available from University website (www.jaduniv.edu.in)...
- Institutional fellowship is not available.
- > No vacancy exists in the Department of Instrumentation Science in this 2nd phase.
- ➤ Application form of the candidates not forwarded by the supervisor may not be considered even after fulfilling the eligibility criteria.
- Admission of the candidate shall depend upon the consent of the supervisor to be allotted.
- ➤ Candidates are requested to follow the website notifications from time to time for any changes in this regard.
